- During the evaluation process the Recruits reflected on biases within internal and external communities.

Learning points:


- Introduction to Culture and Ethnicity
- Human beings identify and affiliate with each other in groups whose members share certain things in common.
- The recognition and preservation of one's identity based on a group affiliation can become a matter of self-esteem and strong personal pride.
- Group affiliations affect not only how an individual act or responds, but also how others interact with or respond to that individual.
- This chart covers your personal, professional and organizational culture. A subcultural group is comprised of people who have an association, most often voluntary, within a larger culture who have common values.
- Culture-A broadly used term that refers to a complex group of shared characteristics including beliefs, values, ways of thinking, behaviors, customs, or traditions.
- An ethnic group is any group that can be distinguished based on shared characteristics such as nationality, common ancestry, language, and common history.
- The term race or racial group usually refers to the categorization of humans into populations or ancestral groups based on various sets of heritable characteristics.
- Past-This region was populated by various indigenous cultures before colonization by the Spaniards.
- Present-California leads the nation in the highest number of diverse cultures coexisting in one state.
- Future-California's demographics are still changing and will continue to reflect the evolving cultural diversity and success of the state.



OC Human Relations Commission Makes Statement on Discrimination and COVID-19

SANTA ANA, Calif. (March 12, 2020) – The Orange County Human Relations Commission issues the following statement on discrimination against the Chinese American and Asian American community due to fears about COVID-19, commonly known as novel coronavirus.

"We stand with the Chinese American and Asian American community against the rise of racist rhetoric, stigma, and paranoia due to fears about COVID-19. We support the right of every person to go to school, work, and other public places without being subjected to race-based discrimination. During times of crisis, people tend to look for scapegoats, but no amount of fear and panic justifies acts of prejudice and discrimination.

We encourage residents who have experienced a hate incident or other racist actions related to the coronavirus outbreak to report it to the OC Human Relations Commission Hate Crime division by calling 714-480-6570 or filing online at http://www.ochumanrelations.org/hatecrime/report/."

In support of the Orange County Human Relations Commission position against discrimination and in light of the recent discrimination-related incident reported at a local Orange County high school, the Orange County Board of Supervisors Chairwoman Michelle Steel, Second District commented, "It is important to have accurate information about the COVID-19 virus from reliable sources. The County is dedicated to protecting the health and safety of all Orange County residents. I encourage all residents of the county to go to the Orange County Health Care Agency's website for the most up-to-date health information."

"As the third most-populous county in California, Orange County prides itself on its rich diversity," said Vice Chairman Andrew Do, First District. "The County continues to promote acceptance and does not tolerate hate of any kind."

"As we show compassion to those affected by COVID-19, we must remember to continue living life but vigilantly acting where we can, such as washing hands and covering coughs and sneezes," said Supervisor Donald Wagner, Third District. "Staying informed is critical to preventing the spread of misinformation; please register your mobile device at AlertOC.com for the latest health updates."

"The best way to prevent the spread of any infectious respiratory illness, including COVID-19, is to practice good hygiene habits," said Supervisor Doug Chaffee, Fourth District. "We should all be taking preventative actions such as washing our hands frequently, cleaning and disinfecting frequently touched objects, avoiding close contact with anyone who may be sick, and staying home if we are sick."
