## Commission Statement in response to Tree Life synagogue shooting

The Orange County Human Relations (OCHR) Commission stands in solidarity with the Jewish community and with the victims of the October 27<sup>th</sup> shooting at the Tree of Life synagogue in Pittsburgh, PA. We find ourselves grieving with the families who have lost loved ones and who are impacted by this act of hate. As leaders of our community, we are horrified that this vicious action resulted in loss of life, especially in the sacred sanctuary of a house of worship. Our commission vehemently stands against this type of heinous crime and decries all acts of hate that target human beings because of their religion, race, national origin, ethnicity, disability, age, gender, sexual orientation, socio-economic status or marital status.

According to the 2017 Hate Crimes Report released by OC Human Relations Council, a nonprofit that partners with the county's Human Relations Commission, 56 hate crimes and 94 hate incidents were reported countywide in 2017. For the third straight year, hate crimes and hate incidents continue to escalate in Orange County. The Commission will continue to lead and support efforts to create awareness and understanding, to engender tolerance and compassion, and to mitigate hate in our diverse communities. ## **WRAP-UP REPORT**

Title: Police and Youth Dialogue

Concept: To strengthen relationships between youth and the Tustin Police Department

Dates: October 25th, November 1st, 8th, and 15th, 2018

Location: Tustin High School

Team: Commission and Community Building Facilitators: Joyce Sanchez and Edgar Medina

Collaborators/Sponsors: Tustin Police Department and Tustin High School

#### Goals:

Assess perceptions among the police officers and youth

Improve relationship between youth and law enforcement

#### Resources:

- · Food, snacks and water for all sessions
- Flip chart notes
- Centerpiece and talking pieces

#### Attendance:

- Officer Robert Nelson, Officer Michael Carter and Officer Tim Crouch
- 8 students (9<sup>th</sup> 10<sup>th</sup> graders)
- 1 Commission & 1 HRC staff members

#### Results:

- Youth and police officers participated in community building activities to help humanize officers and help students feel comfortable and open to express themselves in dialogue
- Both groups discussed the importance of communication, consistent community engagement, and collaboration.
- Police officers and youth had opportunities to discuss how misperceptions are fueled by negative social media, negative personal or family interaction with law enforcement
- Students who participated in this dialogue reside in neighborhoods that are frequently patrolled by Tustin PD
- The positive interactions between Tustin PD officers and youth visibly decreased the youth's nervousness and increased their willingness to engage in dialogue with officers.

#### **Learning points:**

- Meeting with Sergeant Birozy, Lieutenant Fetterling and Assistant Principal Ryon Tanara to discuss purpose and work out the logistics was essential.
- Having the school staff do 1:1 outreach helped target the students who would be most positively impacted by this experience due to their negative perception of police officers
- Small circles provide an opportunity for students to share more and feel less intimidated/uncomfortable
- For future dialogues school need to engage more students to participate in the dialogues
